- With the new year approaching, a REMINDER: When a judge transfers out of a courtroom assignment, all cases that had been
 previously moved out of that courtroom by substitution/recusal of that judge shall automatically transfer back to that courtroom and the
 newly assigned judge, UNLESS the judge to whom it had initially been reassigned, elects to retain the case for a legitimate reason –
 all as stated in Admin. Order 2014-03, which can be found on the 10th circuit website, under 'NEWS'.
- Did you know independent contractor juvenile court GAL's have been moved from the oversight of the Public Defender's office to that of the Courts? They presently are: Anne Bartolo, Louise Natonek, Nina Gougis, Caryn Kamp and Chandra Justice. Floyd Dailey just recently left this position after more than two decades of service to concentrate on his private practice. Thanks Floyd!
- Judge David A. Brown was just appointed by the Illinois Supreme Court to a 3-year term on the Supreme Court Committee on Juvenile Courts. One of many examples of judges serving beyond the normal courtroom docket
