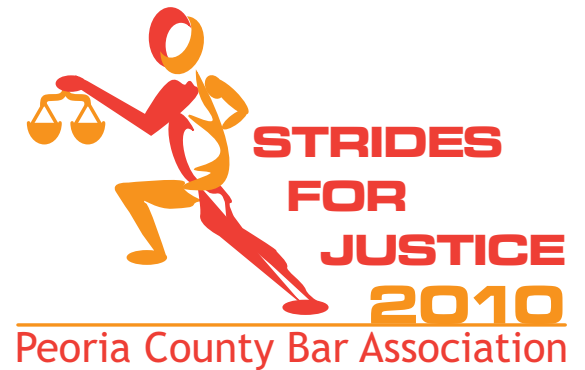


Strides for Justice
