Memorials



On December 8, 2022, a member of the Association, Jack Teplitz, passed away. Jack received his bachelor's degree from the University of Illinois in Champaign. After successfully passing examinations to become a certified public accountant, he graduated from DePaul Law School. He was first employed as a lawyer for the US Department of Justice in Washington D.C. In 1973, he became Corporation Counsel for the City of Peoria in which capacity he served for most of the 1970's. Since then, he was engaged in the private practice of law specializing in local government law, municipal finance, and economic development law. He was appointed special counsel in Normal and Decatur. Among his Normal projects was the downtown Hyatt.

Jack was active in drafting Tax Increment Financing legislation and a law providing for \$20,000,000 in grant funds for the Peoria Civic Center. After leaving City employment, he served on the boards of the Peoria Housing

Authority, Family House, and the Peoria Civic Center. He played a substantial role in maintaining the Peoria Rivermen hockey franchise in Peoria.
