Registration is open for the 2024 Spring Professional Responsibility Seminar! The seminar will take place on Thursday, May 16<sup>th</sup> from 1:00 – 3:45 p.m. through Zoom and includes 2 hours of CLE credit (1 hour of ethics and 1 hour of diversity & inclusion). Topics include:

- **Introducing the New ARDC Administrator**, Lea Gutierrez
- **The ARDC: An Overview and How to Navigate Your Ethical Questions** - ARDC Litigation Counsel (and PCBA member) Dave Collins will provide an overview of the ARDC—its structure, function and procedures. He will discuss how the ARDC can assist attorneys with understanding and applying the Illinois Rules of Professional Conduct and resolving ethical questions. He will discuss how investigations are initiated, what to expect in an investigation and will provide an overview of the disciplinary process.
- **We Need to Talk : Navigating Challenging Conversations about Diversity** by Julia Livingston, ILSCCP - Since 2020, the murder of George Floyd has prompt people to have difficult conversations regarding race. However, little constructive guidance was given regarding how to have these conversations. As a result, although some people engaged in these conversations and were catalysts for change, other people had conversations which may have done more harm than good, and other people simply tried to avoid having these conversations at all. The reality is that many people struggle with having honest and productive conversations about diversity. These conversations require people to discuss potentially sensitive topics ... to speak and listen with empathy ... to be open to accepting constructive criticism ... to be willing to ask questions with an open mind ... and to risk potentially saying the wrong thing. As a result, some people try to avoid ever having these conversations. This course explores how professionalism and civility can provide you with skills to facilitate difficult conversations regarding diversity and help you to be leaders in creating more inclusive environments.
