Another helpful resource is the comedic wisdom acted out by Bill Murray in the movie classic "Groundhog Day." And yes, there is a book on this topic titled "The Wisdom of Groundhog Day" authored by Paul Hannam in addition to many articles by mental health professionals on the same topic. In an article published in The Guardian, Hannam states the three principles he took from the movie. The second factor comes from the time when Phil Connors realizes that improving his inner life does not rely on what power, wealth, or status he may possess or lack. Third, Connors learns to appreciate that he has everything he needs to be happy now. In sum, how we feel about ourselves and our situations is more about our attitude and mindset than we might think. While one may view Hannam's analysis and conclusions as typical pop psychology found in the self-improvement sections of any physical or digital library, seeing the movie again is a worthy experience.
